Eligible artworks, which range from old masters to contemporary art, are required to meet strict eligibility criteria. Griffin Art Partners can operate in various jurisdictions including, but not limited to, Switzerland, Luxembourg and the United Kingdom. Proceeds may be used at the borrower's sole discretion. In return, the borrower is usually required to store the artwork with a third party depositary or a free port.

LINK Management has strong experience in art financing through co-ownership with art dealers and investment in peer-to-peer art lending.

REYL Private Office (Luxembourg) S.à R.L. is in charge of managing the platform and acts as the bondholder representative, ensuring the implementation of all relevant industry standards in terms of bond issuances. KPMG is the auditor.
